## 6. RURAL ELECTRIFICATION IMPLEMENTATION, SUPERVISION AND CONSULTANCY SERVICES

Sabrud Consortium (Nig.) Ltd in collaboration with its sister company, AGIMA FOUNDATION was saddled with the responsibility of extending power supply to rural dwellers in Anambra, Enugu, and Imo states all in the eastern part of Nigeria. Within three years of overseeing this project, Sabrud Consortium (Nig.) Ltd supervised the installation of 300 transformers and extended the network in all these three states by over 210 square kilometers. The effect of this project helped in providing rural access to power and relieving equipments that had been overstretched such as transformers and cables.

The Federal Government of Nigeria awarded this contract to Sabrud / Agima and empowered them to:

- Check working drawing and Bill of Quantities being used by the Contractors in the execution of the works.
- o Ensure adequacy of the Contractors work programme.
- Appraise equipment and manpower situation and site office set up of the Contractors.
- o Assess the quality of the on-shore materials utilized on the works.
- Ensure that the off-shore materials released to the Contractors are actually utilized and committed on the works.
- Monitor progress of the works on the project to ensure that the work schedule is satisfactorily followed and implemented in accordance with the working drawings.
- Evaluate the Contractors' work to ensure compliance with the standards and value for the money expended or to be expended on the project.
- o Prepare and issue quarterly reports of the progress of the works.
- Vet payment certificates submitted by the Contractors.
- Submit detailed and accurate documentation and evaluation of the works in the zone.
- Create Rural Electrification Database at the Zone.

#### 7. REVENUE CYCLE MANAGEMENT

Sabrud operated the Revenue Cycle Management contract for Onitsha and Nnewi Business Units of the Enugu Distribution Zone. Through the deployment of several strategies, Sabrud Consortium Ltd was able to raise the combine revenue of the two Business Units from N60,000,000.00 (Sixty Million naira) to N240,000,000.00 (Two hundred and forty Million naira) within four years. Some of the strategies deployed by Sabrud to achieve this feat include;

#### 8. NATIONAL PREPAYMENT METERING PROGRAM

Sabrud Consortium Ltd was awarded the contract for the Procurement, Installation and management of 161,000 prepaid meters in Enugu Distribution zone in 2006. Sabrud was adjudged the best operator of the project after installing a total of 87,000 meters and successfully implementing the online vending technology.

Prior to the PPM, the cash collection of the zone was N750,000,000.00 (Seven hundred and fifty million naira) only. On completion of the PPM, the cash collection shot up to N950,000,000.00 (Nine hundred and fifty million naira) only due to Sabrud Commercial and revenue collection ingenuity.

# 9. FEDERAL MINISTRY OF POWER (SUPPLY AND INSTALLATION OF SINGLE PHASE AND THREE PHASE ELECTRONIC CREDIT METERS)

Having successfully executed the National Prepaid Metering Program, the Federal Ministry of Power awarded Sabrud a contract to procure and install 15,000 single phase and 10,000 three phase meters valued at N876,875,000.00 (Eight hundred and eighty six million, eight hundred and seventy five thousand naira) only. The LOTS are 4B and 4C.

The supply and installations of these meters had been concluded.

# 10. ENUGU ELECTRICITY DISTRIBUTION COMPANY (CONTRACT FOR THE SUPPLY AND INSTALLATION OF ONE THOUSAND THREE HUNDRED AND SIXTY ONE THREE PHASE LANDIS AND GYR PREPAID METERS)

In April, 2011, Enugu Electricity Distribution Company awarded Sabrud Consortium Ltd a contract for the supply and installation of One thousand three hundred and sixty one (1,361) Landis & Gyr three phase pre-payment meters.

The supply and installation of these meters had been completed.
